

Roane County Overview...

- Over 1 million people within a 50-square mile radius.
- We have the required acreage to develop almost any big box or smaller retail location.
- Two major interstates, nine interstate exits and a traffic count of over 44,500 vehicles daily.
- A new full-service hospital is under construction immediately adjacent to Interstate 40

Roane County is experiencing significant growth and much of it is in the semi-retired baby boomer market. This population is responding to the influx of higher-end residential developments near scenic Watts Bar Lake. A sampling of the new residential developments include:

Ladd Landing is an 800-acre waterfront development for 600 corporate and community condominiums (starting at \$175,000) along with 400 residential units (starting at \$300,000).

Rarity Ridge is a sprawling 1,400-acre development with 2,800 residential units, priced from \$130,000 to \$500,000 plus.

A \$500 million premiere golf course/luxury residential development with some 1,700 new residential has begun on the Roane/Loudon County line.

Grande Vista Bay is a multi-million-dollar gated community with 500-plus, high-end residential units along 10 miles of lakefront, accessed off Exit 350 from Pine Ridge Road to U.S. 70.
